### Kosten verbonden aan belastingterugvorderingen en securities lending transacties

In hoofdstuk 7.2 (*Costs borne by Funds*) zijn paragrafen toegevoegd.

- Er is een beschrijving opgenomen over de wijze waarop de kosten verbonden aan belastingterugvorderingen voor rekening komen van de fondsen. Indien de Beheerder, al dan niet met de hulp van externe (buitenlandse) adviseurs, belastingen terug vordert, dan worden de kosten verbonden aan belastingterugvorderingen in mindering gebracht op voordelen die voortvloeien uit een succesvolle belastingterugvordering.
- Een vergelijkbare beschrijving was al opgenomen met betrekking tot kosten bij securities lending transacties in hoofdstuk 2.2. Deze beschrijving voor securities lending transacties is nu voor consistentie tevens in hoofdstuk 7.2 opgenomen. Indien securities lending toegestaan is voor een MM Fund, wordt dit vermeld in de Fund Specificaties van het desbetreffende fonds.

### Responsible Investment (RI) approach

Voor de volledigheid noemen we dat in de prospectus update van 8 December 2022 er in de Fund Specificaties van een drietal fondsen per abuis een zinsnede is weggefallen en deze zin is nu weer in de Fund Specificaties opgenomen. Het betreft de zin “*Fund holdings are periodically screened on*

*alignment with the Sustainable Development Goals of the United Nations*” in de Fund Specificaties van de volgende fondsen:

- MM Emerging Markets Fund
- MM Long Term Investment Fund
- Aegon Global Multi Manager Emerging Markets Fund

In de praktijk heeft de betreffende screening gewoon plaats gevonden.

## Costs ensuring from tax reclaims and costs ensuing from securities lending

The following cost paragraphs are included in section 7.2 (*Costs borne by Funds*) of the Prospectus.

- Wording is included to describe the manner in which fees related to withholding tax reclaims are borne by the Funds. When the Manager, with or without the help of external (foreign) advisors, reclaims withholding tax, the fees associated therewith shall be deducted from benefits that follow from a successful tax reclaim.
- A similar description was already included in relation to fees for securities lending transactions in the section 2.2 on risks. For consistency reasons, this description is now included in section 7.2 as well. Whether securities lending is permitted for a MM Fund is disclosed in the Fund Specifications of each fund.

## Responsible Investment (RI) approach

For the sake of completeness, we would like to inform you that in the prospectus update op 8 December 2022 a sentence previously included in the Fund Specifications of 3 funds was accidentally left out and we have now reinserted this sentence. It concerns the sentence “*Fund holdings are periodically screened on alignment with the Sustainable Development Goals of the United Nations*” in the Fund Specification of the following funds:

- MM Emerging Markets Fund

- MM Long Term Investment Fund
- Aegon Global Multi Manager Emerging Markets Fund

The screening as referred to in the sentence has taken place.
